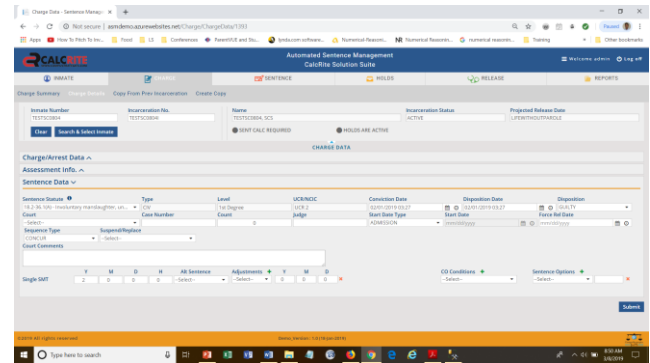

Charge & Sentence Data Capture

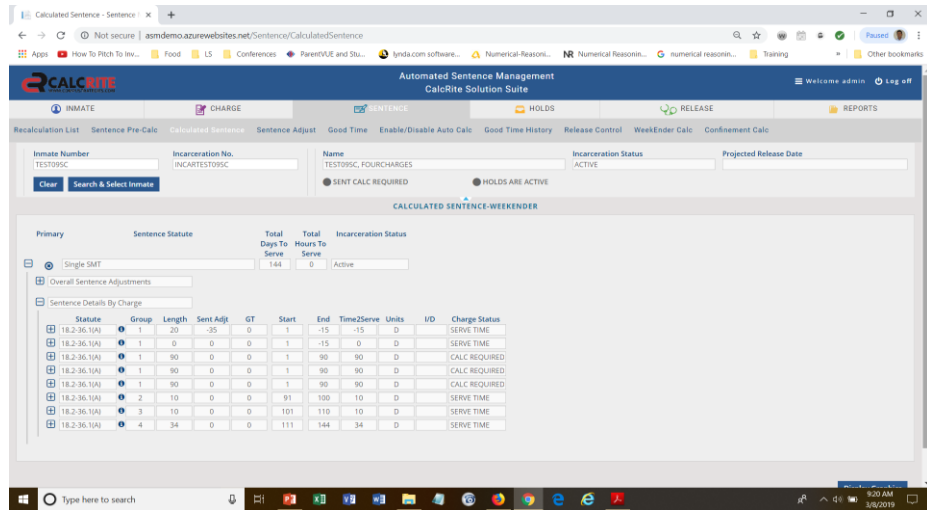
- All fields can be configured to be visible/hidden.

Sentence Calculations

- Automatic Release Date calculation for contiguous sentences based on release control term.
- Definition of multiple Sentence Calculation Methods automatically selectable on configurable selection criteria from any fields in database.
- Definition of multiple Sentence Term calculations per defined Sentence Method and designation of default Release Control Sentence method.
- Ability to switch release control between Sentence Methods
- Ability to sequence sentences in any order with user-defined default order.
- Ability to process Dead Time
- Ability to process Interrupt Charges
- Forced Release Date processing at charge and overall sentence level
- Configurable to calculate based on perpetual calendar or fixed month and year times.
- Sentence Adjustment processing at both charge and overall sentence level.
- Automatic sentence recalculation notification if data affecting sentence calculations changes.
- Definition of multiple Statutory Good Time processing methods that support automatic calculations based on configurable selection criteria and/or manual entry of good time.
- Definition of multiple Meritorious Good Time processing methods calculated based on user defined rankings such as Housing or Job rankings, or entered manually.



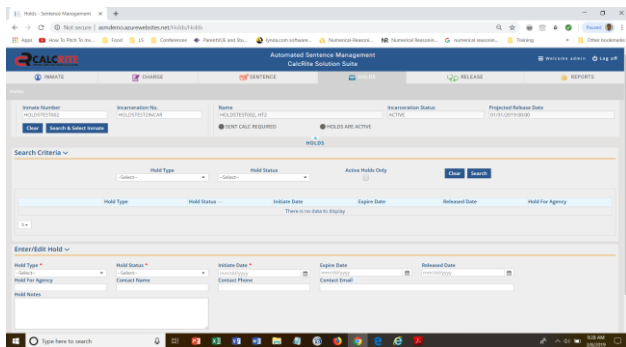

Holds Processing

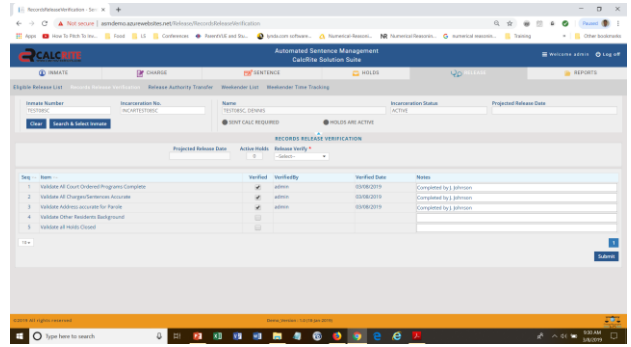
- Capture/store user entered holds/detainers.
